- Each team will be responsible to dress one player in goaltending equipment (if there is one full-time goaltender, that goal tender will rotate between teams each week)
- All games in accordance with tin-league rules (exception 15 min periods)
- Price **ONLY \$85** for a six game session which includes, ice, referee, and a scorekeeper
- **Subs will be allowed at \$14 per game. Must be USA Hockey Registered.**
